

# RESOLUTIONS FOR ADOPTION BY THE ORDINARY GENERAL ASSEMBLY OF $30^{TH}$ JUNE 2022, BY CORRESPONDENCE

#### 1. APPROVAL OF CIGRE ANNUAL 2021 ACCOUNTS

Jean Jacques JULIAN, appointed as official Statutory Auditor of CIGRE by the 2020 General Assembly for a 6-year period, has certified the CIGRE Accounts and the Financial Situation as at 31<sup>st</sup> December 2021.

### **RESOLUTION #1**

#### 2. APPROVAL OF THE ALLOCATION OF CIGRE ANNUAL 2021 RESULT
